

OTHER OFFICERS ALSO ELECTED

Bonner Burton, a member of Troop 316 in Newport News, and Kiskiack Chapter, has been elected Chief of Kecoughtan Lodge. Bonner was elected at the September Ordeal at Camp Chickahominy.

He is a Eagle Scout, member of the Peninsula Council Executive Board and a Vigil Honor Member of the Order of the Arrow.

Also elected were Jeff Godby, a member of Troop 3, Mattaponi Chapter, First Vice Chief; Robbie Kirkpatrick a member 0f Troop 144, Piankatank Chapter, Second Vice Chief; Drew Wooldridge of Troop 158 also Kiskiack Chapter, Treasurer; Eric Stupar from Troop 13, Pamunkey Chapter, membership secretary; and Ray Ellis from Troop 103, Piankatank Chapter will serve as recording secretary.

CHANGES LISTED IN NEW ORDER OF THE ARROW BOOK

The new 1989 Order of the Arrow Handbook contains several important changes and emphasizes others that were not as clear in earlier handbooks.

The most important of these is the status of Arrowmen who are 18 through 20 years of age. We all know that they have always been able to vote in lodge business decisions and to hold office. Yet they have not been considered as youth members in terms of their own election or in the election of other youth. Now that is changed. Effective immediately, all members of the BSA who are under the age of 21 will be totally under the youth member procedures. They must be First Class or better in the Boy Scouts of America; they must have the same camping experience as other youth; they must have their eligibility and Scouting spirit certified by the unit leader; and they will be part of the youth election process, both as voters and as those to be voted upon. [(Contradictory language on pages 102, 109, 110 and 111 of the new Handbook is being changed by an errata sheet due out soon S. E. Region O.A. Update, 6-30-89)]

Two paragraphs in the new Handbook emphasize wearing the flap patch of the local lodge and none other and tie it to dues-paid membership. They are "Lodge membership", pg 48, which states:"....may be members of only one lodge, that being the lodge chartered to the council where they reside and have their principal Scouting registration." and paragraph 5, pg 103: "No Arrowman is authorized to wear the O.A. flap patch of a lodge he is not a member of, even though he may have been inducted into the Order of the Arrow by that lodge." Taken together and stated simply, they say: "You can be a paid-up member of only one lodge. It must be the one in which you are a paid-up BSA member. You can wear only the flap patch of that lodge. If you are not a paid-up member of that lodge. you cannot wear any flap patch or any O.A. insignia."

Finally, attention to the revised eligibility requirements for all adult candidates clearly points toward fewer adults being inducted. Those requirements appear on page 101 of the new Handbook. Even unit adults are no longer elected by the unit committee; they can only "recommend" one adult to the Lodge Executive Committee, and that one must pass stringent tests. No other unit Scouters may even be recommended. District and Council Scouters must be similarly recommended to the youth of the Lodge Executive


Hat design contest rules are as follow:


CHANGES LISTED IN NEW ORDER OF THE ARROW BOOK
